South African Pork Producers' Organisation ("SAPPO") is committed to protecting your privacy and developing technology that gives you the most powerful and safe online experience. This Statement of Privacy applies to the https://www.worldofpork.com website ("World of Pork Website") and governs data collection and usage. By using the Website, you consent to the data practices described in this statement.

1. COLLECTION OF YOUR PERSONAL INFORMATION

- 1.1 SAPPO collects personally identifiable information, such as your e-mail address, name, surname, or telephone number. SAPPO also collects anonymous demographic information, which is not unique to you, such as your ZIP code, age, gender, preferences, interests, and favourites.
- 1.2 There is also information about your computer hardware and software that is automatically collected by SAPPO. This information can include: your IP address, browser type, domain names, access times and referring website addresses. This information is used by SAPPO for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the World of Pork Website.
- 1.3 Please keep in mind that if you directly disclose personally identifiable information or personally sensitive data through SAPPO public message boards, this information may be collected and used by others. Note: SAPPO does not read any of your private online communications.
- 1.4 SAPPO encourages you to review the privacy statements of websites you choose to link to from SAPPO so that you can understand how those websites collect, use, and share your information. SAPPO is not responsible for the privacy statements or other content on websites outside of the World of Pork and World of Pork family of Websites.

2. USE OF YOUR PERSONAL INFORMATION

- 2.1 SAPPO collects and uses your personal information to operate the World of Pork Website and deliver the services you have requested. SAPPO also uses your personally identifiable information to inform you of other products or services available from SAPPO and its affiliates. SAPPO may also contact you via surveys to conduct research about your opinion of current services or of potential new services that may be offered.
- 2.2 SAPPO does not sell, rent or lease its customer lists to third parties. SAPPO may, from time to time, contact you on behalf of external business partners about a particular offering that may be of interest to you. In those cases, your unique personally identifiable information (e-mail address, name, surname, telephone number) is not transferred to the third party. In addition, SAPPO may share data with trusted partners to help us perform statistical analysis, send you e-mail or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to SAPPO, and they are required to maintain the confidentiality of your information.
- 2.3 SAPPO does not use or disclose sensitive personal information, such as race, religion, or political affiliations, without your explicit consent.
- 2.4 SAPPO keeps track of the websites and pages our customers visit within SAPPO, in order to determine what SAPPO services are the most popular. This data is used to deliver customized content and advertising within SAPPO to customers whose behaviour indicates that they are interested in a particular subject area.
- 2.5 World of Pork Website(s) will disclose your personal information, without notice, only if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on SAPPO or the Website; (b) protect and defend the

rights or property of SAPPO; and, (c) act under exigent circumstances to protect the personal safety of users of SAPPO, or the public.

3. USE OF COOKIES

- 3.1 The World of Pork Website use "cookies" to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a Web page server. Cookies cannot be used to run programs or deliver viruses to your computer. Cookies are uniquely assigned to you, and can only be read by a web server in the domain that issued the cookie to you.
- 3.2 One of the primary purposes of cookies is to provide a convenience feature to save you time. The purpose of a cookie is to tell the Web server that you have returned to a specific page. For example, if you personalize SAPPO pages, or register with World of Pork Website or services, a cookie helps SAPPO to recall your specific information on subsequent visits. This simplifies the process of recording your personal information, such as billing addresses, shipping addresses, and so on. When you return to the same World of Pork Website, the information you previously provided can be retrieved, so you can easily use the SAPPO features that you customised.
- 3.3 You have the ability to accept or decline cookies. Most Web browsers automatically accept cookies, but you can usually modify your browser setting to decline cookies if you prefer. If you choose to decline cookies, you may not be able to fully experience the interactive features of the SAPPO services or World of Pork Website(s) you visit.

4. SECURITY OF YOUR PERSONAL INFORMATION

4.1 SAPPO secures your personal information from unauthorised access, use or disclosure. SAPPO secures the personally identifiable information you provide on computer servers in a controlled, secure environment, protected from unauthorised access, use or disclosure. When personal information (such as a credit card number) is transmitted to other websites, it is protected

through the use of encryption, such as the Secure Socket Layer ("SSL") protocol.

5. CHANGES TO THIS STATEMENT

5.1 SAPPO will occasionally update this Statement of Privacy to reflect company and customer feedback. SAPPO encourages you to periodically review this Statement to be informed of how SAPPO is protecting your information.
